Used fluid samples carry no commodity codes as they have no commercial value. We appreciate some couriers have to type something in this box, so for this purpose alone a suitable one would be Lubricating oil **HS27101981**, however, please note that no duties for goods will be accepted by this lab as we have a full NIRU see below and if you calculate duties are owed then you have calculated this incorrectly and NIRU means there are no duties.
